OCTOBER, NOVEMBER, DECEMBER 2014 (1ST QUARTERLY REPORT)

- 1st Modular Seminar between Professor Davide Galliani, Module Coordinator and Sergio D'Elia, Founder and currently Secretary of Hands Off Cain to discuss the organization of the 2015 Annual Congress of Hands Off Cain (main topic: Life Imprisonment) and the possibilities to complaint versus Life Imprisonment to Italian Constitutional Court and European Court of Human Rights (ECHR). Brief analysis of the connection between death row phenomenon of death penalty and of long term imprisonment (in particular, first debate about Jones case, US, California, Central District, July 16, 2014: to wait for death penalty execution more than 20 year is a cruel and unusual punishment; in this manner, death penalty has changed his meaning because it became "life in prison, with the remote possibility of death"). Brief analysis of the Leger case, European Court of Human Rights, April 11, 2006.
- 2nd Modular Seminar between Professor Davide Galliani and Professor Andrea Pugiotto, University of Ferrara, Italy. Debating about one next book on Italian Life Imprisonment named "ostativo" ("Blocked" Life Imprisonment) in which will be two parts: "Blocked" Life Imprisonment in a view of one Lifer (Carmelo Musumeci), Constitutional problems of "Blocked" Life Imprisonment (Andrea Pugiotto).
- 3rd Modular Seminar between Professor Davide Galliani and Giulio Pagano, student of the University of Milan, Italy. Discussion about Life Database, one of the most important Research Product (a World Database of Life Imprisonment Free State).
- 4th Modular Seminar between Professor Davide Galliani and Nadia Bizzotto, Prisons Responsible of the Pope John XXIII Association. The seminar involves also Stefano Anastasia e Susanna Marietti (from Antigone, an important Italian Ngo dealing with human rights protection in penal and penitentiary system). The scope of the seminar is find one Lifer close in Italian Hospital (Psychiatric) Penitentiary after the new Parliamentary Act no. 81 of 2014.
- Lifers Questionnaire Initiative. Professor Davide Galliani, Sergio D'Elia, Andrea Pugiotto and Nadia Bizzotto prepared a Lifers Questionnaire. The goal is to circulate it into Italian prisons. The questions are: Lifer Generality (Name, Surname, Date of Birth), Lifer Imprisonment (current prison, start date of the current imprisonment, type of imprisonment regime, type of Life Imprisonment), Lifer Health Conditions (disease diagnosed in prison, no-diagnosed diseases, any surgeries, any impairments).

The Mexico Report (in Italian and in English) is composed by two modules: the first, open, conversational, with questions and answer; the second, a table, with column that involve Death Penalty (Yes, No, Year of Abolition), Life Imprisonment (Yes, No, Maximum Penalty, Parole), Pardon, Inmate (Total, Lifers), International Conventions, Others Information, Sources.
