From October 2015 to September 2016: Inner Life Working Group (ILWG, subgroup of "The Right to Hope" Project) had 50 meetings (duration of each: 5 hours minimum) to translate,

# - ITALIAN CONSTITUTIONAL COURT

The Project (in particular, Professors A. Pugiotto and D. Galliani, and ILWG members) worked on question of constitutionality of the italian No Escape Life Imprisonment.

The goal: publish a sort of document ("keys in hands") for Italian Judges useful to constitutionality recourse to the Constitutional Court.

Finally, the doc. has been published, in www.dirittopenalecontemporaneo.it, on of the most Italian widespread law review.

#### - DEGREE THESIS

Other ILWG members take a Degree. In particular, Giulio Pagano (on Strasburg case law about Differentiates Prison Regimes: vote 109/110) and Marta Stroppa (on Anders Breivik Case, vote: 110/110 cum lode). After Degree, Oxford University (UK) accepted Pagano request for Master, and Tilburg University (Netherland) accepted Stroppa.

Also Pagano and Stroppa thesis have been published in Ristretti Orizzonti, www.ristretti.it, one of the most important Italian internet site on prisons and rights of prisoners.
